 - Volunteer Tea Thursday (June 12th) if job action affects
 - o Parents having to step up a bit
 - o "Charlie and the Chocolate Factory" at PGSS cancelled

- (b) Trustee Report (Betty Bekkering)
 - o In the middle of a climate of labour unrest
 - Receiving emails from teachers and parents asking what side school trustees are on?
 - Betty has a strong union background 40 years
 - Executive President of CNC support staff
 - Negotiator
 - Can't take sides
 - BCPSEA have not involved school trustees
 - Signed a Code of Ethics & took Oath of Office
 - Can't be involved in negotiations
 - Hope is good bargaining at the table
- (c) Superintendent Report (Brian Pepper) complex situation
 - Reports to trustees (employer) and Minister of Education (government)
 - Receive emails re: direction/guidance from government Q & A on website non-discussion item in terms of action
 - Instruction to my staff (principals, vice-principals, administration, etc. "Hard on issue & soft on people"
 - Ouestion if there is a lot that can be done to calm situation?
 - People need to make decisions
 - "Stick to the knitting" "knitting" is the learning
 - Respectful need to listen to both sides
 - There are two perspectives

- You need to form your own opinions
- o Proud of all staff and teachers not taking it into the classroom
 - Temperance
 - "Boiling Cauldron" it is a volatile situation
- o Dennis Fudge asked question about provincial exams
 - Education minister says exams will go ahead
 - Think exams will be changed, i.e., Social Studies 11 & English 10 with written components will be electronic instead of written

(d) PGDTA Report – (Tina Cousins)

- Not here to refute or deny anything
- Doing everything they can
- Have good relationship in this district
- Need to focus on children and learning
- Incredibly difficult on teachers
- o Tina explained details of lockout by employer administrative in nature
 - Stage 1 89% strike vote in March
 - Stage 2 rotating strikes
 - Very complex situation
 - Bigger that field trips and other things
 - Going on 12 years
 - Lockout is big divisive
 - A lot of conversations with Superintendent Pepper maneuvering
- Want parents to keep informed
- Everyone is uneasy
- o Negotiation team needs government to come to table with the necessary resources
 - 8 items have been tabled
 - Government is "entrenched" no movement on their part
 - Strike vote is leverage at the bargaining table
 - Looking at a "showdown"
- Don't know how report card situation will play out
- o Appreciate it if talk to trustees respectively

(e) CUPE Report – (Karen Wong)

- o "Bargaining fatigue" settled in 6 days & 5 months & 2 years
- o Tentative agreement
- Biggest part framework agreement. Is on BCSchools.Cupe.ca website
- 5.5% over 5 years
- Fully funded by government
- o 1st week of July to bargain locally
 - July 2nd & 3rd at bargaining table
 - Deadline to ratify November 20th
- o 10 out of 12 proposals recognized 9 proposals firmed up see BCSchools.Cupe.ca website
